Three Goals Areas Developed by NLT August

- 1. Recruiting more volunteers
- 2. Developing more leaders
- 3. Maintaining quality



1. Recruiting more volunteers

- a. Establish a recruitment & retention committee
 - Update: Established Dan Arnold, Chair
- b. Local marketing focus/word of mouth
 - i. Increase prospects by 25% compared to 2016
 - Update: Improved 5.77%
 - ii. Improve the conversion rate of prospects by 5% compared to 2016
 - Update: Improved 39.26%



1. Recruiting more volunteers

- a. Develop an onboard and retention strategy
 - i. Initial contact within 7 days
 - ii. All 2 years or less volunteers/prospects assigned a mentor
 - Update: Mentoring pilot established
 - i. Better vetting of prospects to increase the conversion rate compared to 2016



2. Developing more leaders

- a. Reduce number of positions leaders hold
 - i. Leaders holding more than 2 leadership positions reduced by 20% in 2 years
 - Update: Without Instructors increased 11.25%
 - With Instructors increased 3.26%
- b. Succession planning
 - i. Within one year, 100% of SC's to provide RC with 2 possible successors
 - ii. Grooming 50% of DC's have an assistant/successor within one year



2. Developing more leaders

- c. Mentoring
 - i. Identifying possible future leaders and keeping a list of at least5 at the SC level
 - ii. Inviting future leaders to meetings like State Meeting
 - iii. Build more "assistant-to" positions throughout organization
 - iv. Better explanation of Tax-Aide volunteer organization structure



3. Maintaining quality

- a. Develop QR process for all sites based on a set standard review protocol
 - i. Standard module on how to perform QR for dedicated review
 - ii. Standard module on how to perform QR for peer review
 - Update: In Development
- b. Require NTTC QR training program
 - Update: In Development
- c. Develop an evaluation tool to measure our accuracy rate by 2018



Vermont Tax-Aide Program Goals and Activities

1. Recruiting more volunteers

- a. Local marketing focus/word of mouth
 - i. Broaden recruitment articles to include non-tax prep positions
 - ii. Use OSHC articles
 - iii.Improve the conversion rate of prospects
- b. What should we do for Onboarding?
 - a. Contact prospects within a few days
 - b. Follow-up as needed
 - c. Consider mentoring



Vermont Tax-Aide Program Goals

2. Developing more leaders

- a. Reduce number of positions leaders hold
 - a. Can you go away for 2 weeks during the tax season?
- b. Develop SMT Model at District Level
- c. Succession planning
 - i. Identify possible successors
 - ii. Groom, mentor, train, assign
 - iii. Invite future leaders to meetings like State Meeting
 - iv. Build more "assistant-to" positions throughout organization
